

# Q1 Using Leeds Parks and Green Spaces (please only complete this survey if you can answer)



Q5 Herbicide: Leeds City Council does not use insecticides, but does use some herbicide (usually glyphosate) in paved areas to stop plants damaging path edges, walls etc. It's also a cost-effective way to stop grass out-competing newly-planted trees. But herbicide can cause grass to go brown and it may kill plants which provide vital nectar for insects. (Strimming is used increasingly less because it can cause noise nuisance and various types of damage, including to hedgehogs and other small mammals, so we have not included it as an alternative to herbicide):






